Carlton's Cleanliness and Lygon Street Improvements

Our efforts to maintain a clean and green environment in Carlton have been ongoing, and I am pleased to report that the area is looking better. Significant strides have been made improving the cleanliness of our streets, with more frequent waste collection and initiatives to encourage responsible waste disposal. Changes to parking still remains a challenge.

In addition to this, improvements to Lygon Street have been a key focus this year. We've collaborated with Carlton Inc. to start the Lygon St. Market on the 1st Sunday of the month and are making exciting plans for Lygon Street to be a more enjoyable and accessible place for all. It's heartening to see the positive changes taking root after the disaster of Covid, with the street becoming once again a hub of activity for residents and visitors alike.

5. Advocating for AFFORDABLE HOUSING in the community.

Juggling these priorities has been no small feat, but our determination to maintain a balanced approach has been key in ensuring that no area is neglected.

Topical Issues

City of Melbourne - CoM - your closest level of government

Friends and neighbours,

I am delighted to be back to serve my community for another 4 years on Melbourne City Council. Here we are on the day the new Council was sworn in, in the old chamber at Melbourne Town Hall.

What can I tell you about the new Council? Six councillors are returning/re-elected, while 5 are new. Four of last term's councillors did not recontest.

Only 3 out of the 11 are women; down from 4 last term and 5 the term before.

As you will surely know, Nick Reece (ALP) was elected Lord Mayor of Melbourne, with Roshena Campbell (Lib) elected Deputy Lord Mayor. Two further Councillors were elected on the Team Reece ticket: 'father of the house' Kevin Louey and Vic Market trader Mark Scott.

All remaining 7 councillors are each from separate tickets competing in the election:

Owen Guest (Lib), myself (Greens), Gladys Liu (Team Kouta), Phil Le Liu (Team Wood), Rafael Camillo (Gary Morgan), Andrew Rowse (Independent) and Davydd Griffiths (ALP).

We were welcomed to Country with a smoking ceremony by Wurundjeri elder Uncle Colin Hunter, and sworn into office on 19 November, and will hold our <u>first Council meeting of the term on 26</u> <u>November</u>. We have 8 days of induction training as a Council. We can hope the City of Melbourne's motto holds true: *vires acquirit eundo*, 'we gather strength as we go' (borrowed from Virgil's *Aeneid*, 19 B.C.E).

A new history of the City of Melbourne

At this milestone when we are focussed on the future of Melbourne, may I commend to you the latest history of the municipality. Written by independent professional historian Dr Amanda Lourie, it's a 50-page truth-telling <u>submission to the Yoorrook Justice Commission</u>.

The truth commission is not just for First Nations Victorians to commit their experiences to the public record. It's also an opportunity for institutions to re-examine their history and their impact on the First Peoples of this place.

Before federation in 1901, before the founding of the colony of Victoria in 1851, the City of Melbourne was the first colonial government in the place known as narrm on Wurundjeri and Bunurong Country. Amanda has dug into public archives and unearthed lesser-known events in the history of Melbourne Town Council – which soon became Melbourne City Council – from its first meeting in a pub in 1842, to the present day.

I don't think anyone has written this history before, so it's likely no-one has hitherto known all the events recounted in this document. It's something all Melburnians should know.

No sausage and no sizzle - 2024 Melbourne City Council Election.



It was not that long ago we lined up at a local polling booth to cast a vote for our preferred local council candidate. Waiting in the line was for many distracted by a sausage in a slice of bread provided at minimal cost by a local club or organisation.

It raised funds, satisfied the hunger and took time off waiting in the line. The democracy sausage as it became known in the 1980's satisfied the hunger for democracy.

The polling booth at a local school, community centre or church was a community event even though it involved a personal and private vote for a preferred candidate.

The polling booth also required candidates to have local supporters to hand out how to vote cards in a last minute attempt to influence voters.

The sausage together with the polling booth were a very local thing! It became synonymous with democracy and built a sense of community.

The recently held Melbourne City Council election lacked the sizzle. Only two thirds of votes were received and 5% were informal.

The general view was that the campaigns failed to interest voters and information on the Teams was limited to the Lord Mayoral candidate.

The campaigns also provided no vision for the city's future nor policies that reflected the interests and needs of residents and local business.

The election however did shine a blinding light on the electoral provisions of the City of Melbourne Act and revealed their shortcomings and pitfalls.

During the election campaign it became pretty obvious that funding and preference deals provided the best insight into the motivation, credibility and suitability of candidates running for the Council and also skewed the result.

The source of election funding was hidden with most candidates declining to have the amount and source of their funding announced until 40 days after the election result.

No doubt the benefactors and the beneficiaries of the successful campaigns will be revealed in conflict of interest declarations in future council decision making.

The Age Editorial on16 October 2024 called for reform of the City of Melbourne Act: 'The 'Voting system must change, It's not a preference, it's a demand'.

The editorial reported on the backroom deals and preference flows between candidates that it said could result in an unexpected Lord Mayor for Melbourne. 'As The Age's reports have made manifestly clear reform is needed. To do nothing is to cast integrity out the window'.

Then on October 19, 2024 The Age Editorial Editorial asked 'Who's the best for Melbourne? The Age cannot endorse mayoral candidates'.

It revealed that the leading Lord Mayoral Team leaders were unwilling to accept The Age's invitation to reveal their campaign donors in real time. It went on to say that transparency in this campaign has been severely lacking, including for party membership. The complex flow of preferences it stated results in unexpected and unintended outcomes.

The election campaign has resulted in calls for a review and reform of the City of Melbourne Act and its electoral provisions.

We need electoral provisions that return the City of Melbourne to real democracy.

We need one vote one value, the reintroduction of Wards, attendance voting and the election of the Lord Mayor and Deputy Lord Mayor by the council.

The Carlton Residents Association is well prepared to represent the interests of its members and friends over the next 4 years with its 'Agenda for Carlton' providing a platform for its advocacy role to the Council.



including here in Victoria, shows that the climate crisis is already at our doorstep. Our people's survival is on the line. Their stories are important and need to be amplified."

Anasina's perspective and experience is crucial, especially as we continue to see the Labor State Government's alarming trend of approving new fossil fuel projects. With more than a dozen new gas projects in the pipeline, local communities are forced to fight off disastrous projects time and time again. Near Geelong, the local community is again having to fight a giant gas terminal proposed for Corio Bay - a project that has already been rejected once. The Greens are amplifying the community's opposition in Parliament.

Community pressure is a powerful force for change. Recently, fossil fuel giant TGS pulled out of what would have been the world's largest seismic blasting project here in the Otway Basin, on Southern Sea Country, following immense community pressure. This project would have caused catastrophic harm to the marine environment to search for new oil and gas under the sea floor. Years of opposition from First Nations groups, ocean lovers, and the Greens has paid off.

But communities shouldn't have to do this work. Governments shouldn't be approving new fossil fuel projects in the first place. We are in a climate crisis. We don't need any more oil and gas. In fact, Victoria exports more gas than we could ever use.

Anasina's background as a community advocate and her deep understanding of climate issues will be an incredible asset as we continue to push the Labor government to prioritise people and planet, not fossil fuel profits.


